### Announcement No. 11/2025

## of October 6, 2025

of the Vice-Rector for Student Affairs and Education of the Medical University of Warsaw, regarding the submission of applications for financial assistance for students in the 2025/2026 academic year.

Pursuant to § 3 of the Regulations on benefits for students of the Medical University of Warsaw, introduced by the Rector's Order No. 198/2025 of 3 October 2025, in consultation with the Student Government, it is ordered as follows:

### I. Applications

- 1. Applications for benefits for the 2025/2026 academic year regarding:
- a) social scholarship;
- b) Rector's scholarship;
- c) scholarship for persons with disabilities;
- d) allowances,

# will be accepted during the period:

### from the date of this Announcement until October 22, 2025.

1. Applications are submitted in two stages:

**Stage I** – electronic registration of the application for benefits via the MUW Virtual University website: <a href="https://wd.wum.edu.pl">https://wd.wum.edu.pl</a>, application submission instructions are available on the MUW Virtual University in the APPLICATIONS -> APPLICATION FORM -> SCHOLARSHIP APPLICATION INSTRUCTIONS section,

and

**Stage II** – submission to the appropriate dean's office of the signed application printed from the MUW Virtual University website, along with the required attachments, listed in Appendices No. 1 and No. 2 to the Regulations on Benefits for Students of the Medical University of Warsaw (Rector's Order No. 198/2025 of October 3, 2025).

Student application forms for social scholarships, the Rector's scholarship, allowances, and scholarships for persons with disabilities are printed from the Virtual University.

Original applications with attachments may be submitted as follows:

Documents should be submitted in a secured envelope containing the following information: student's name and surname, student index number, year of study, and field of study/faculty.

No applications will be accepted from October 23 to November 19, 2025, with the exception of applications for assistance, which will be accepted on a continuous basis.

#### II. Income Thresholds

- 1. The income threshold entitling to receive a social scholarship is PLN 1,908.90.
- 2. The base year is 2024.
- 3. The total monthly amount of the social scholarship and the Rector's scholarship paid to a single student cannot exceed PLN 3,560.60 (38% of a professor's salary pursuant to Article 92, paragraph 3 of the Act of July 20, 2018, the Law on Higher Education and Science, (consolidated text: Journal of Laws of 2024, item 1571). 4. If the monthly income per family member does not exceed PLN 823 net per person, the student must attach to the application for a social scholarship a current certificate from a social welfare center regarding the income and financial situation of their family, as referred to in § 23 of the Regulations on Benefits for Students of the Medical University of Warsaw.
- 5. In the cases referred to in § 22, paragraph 5, point 5 of the Regulations on Benefits for Students of the Medical University of Warsaw (Rector's Order No. 198/2025 of October 3, 2025), the minimum monthly student income at which they may apply for a social scholarship without reporting the income earned by the individuals referred to in § 22, paragraph 2 of the Regulations on Benefits for Students of the Medical University of Warsaw is PLN 1,696.80 net. 6. The income for 2024 per 1 hectare of conversion area is PLN 5,429. (Announcement of the President of the Central Statistical Office of 22 September 2025 on the average income from work in individual farms from 1 hectare of conversion area in 2024)

1. Applications submitted by October 22, 2025, will be reviewed by the Scholarship Committee on the following dates:

- a) social scholarships, allowances and scholarships for persons with disabilities November 20, 2025.
- b) Rector's scholarships December 2 3, 2025.

# **IV. Payment Dates**

Social scholarships, allowances and scholarships for persons with disabilities for October and November 2025 will be paid in their total amount by November 30, 2025. Rector's scholarships will be paid in December 2025, with a compensation for October and November
