ATTENTION!

• In case of subjects taken at bilingual matura exams, <u>only</u> the results of exams taken in Polish will be taken into account in the recruitment process.

• In case of a different grading scale (not listed in the tables), the conversion of the grades into qualifying points will take place according to the principle equivalent to the principle applied in the tables.

• If the Candidate has a certificate/diploma/other document issued abroad, in a country not listed in the tables below, recognition by the WKR of the document entitling the Candidate to undertake studies at a specific level may take place on the basis of data from NAWA or NUFFIC. The conversion of grades into points will take place according to the scale of grades most similar to those presented in the tables.

• If the document does not contain a specific test level or documented confirmation of the equivalence of the obtained result to a given level, this result will be converted to the basic or extended level according to the rules contained in Appendixes 2 - 19.

• For qualifications for studies conducted in the Polish language, in the case of foreign matura examinations, only the results of external examinations valid on the date of closing the IRK system before the announcement of the first list of qualified candidates can be accepted.

• If the secondary school-leaving certificate or certificate/diploma/other document entitling to apply for admission to higher education in the Republic of Poland shows one grade for two subjects, i.e. the subject is combined - e.g. physics with chemistry, the grade may be used only once.

• The final recalculation of the grades in the required subjects presented by the Candidate and taken into account in the selected field of study is decided by the relevant Faculty Admissions Committee.

• Foreign applicants who have obtained a certificate or other document issued abroad that is not a document referred to in Article 7 paragraph 1 item 1 (d), (e), (f) or (g) 'Conditions, procedure, start and end dates, and method of recruitment for the first year of studies in the academic year 2025/2026 at the Medical University of Warsaw', will be eligible <u>for studies conducted in Polish solely</u> on the basis of the results of the WUM Entrance Examination or may be eligible on the basis of the results of the universities on examination sheets for the matriculation examination prepared by the CKE and assessed according to the rules established by the CKE.
